#### **HUMAN RIGHTS ACT STATEMENT**

The Human Rights Act 1998 makes it unlawful, subject to certain expectations, for a public authority to act in a way which is incompatible with a Convention Right. However when a planning decision is to be made there is further provision that a public authority must take into account the public interest. Existing planning law has for many years demanded a balancing exercise between private rights and public interest and this council's recommendations on planning applications take into account this balance. If there are exceptional circumstances which demand more careful and sensitive consideration of Human Rights issues then these will be taken into consideration by South Somerset District Council as the Planning Authority when they determine the applications.



#### 9/126 FEEDBACK FORM

One comment was received saying it was easier to receive the agenda via email with the electronic link to the individual applications. In response to those requesting more information to be included on the agenda, this is not possible because the District Council is no longer involved with the process of preparing the Planning Committee agendas and therefore the onus is on Members to investigate the applications via the electronic link before each of the meetings.

A request was made to include a column for notes on the plans list. Space is very limited but we have managed to put a small column in.

A concern was raised that the public sitting along the front wall of the Chamber could not see the screen. Hopefully this will be resolved when the new projector and screen is installed.
