Minutes of the meeting of Yeovil Town Council held on Tuesday 7<sup>th</sup> March 2017 at 7.30pm in the Town House, 19 Union Street, Yeovil BA20 1PQ

**Present:** Cllrs D Shutler (Chairman & Mayor), D Recardo (Deputy Mayor), F Boieangiu, P Chandler; J Conway, A Kendall, M Lock, P Lock, T Lock, S Lowery, G Oakes, E Potts-Jones, F Purbrick, W Read, M Roper, A Smith and R Stickland.

**In Attendance:** A Card (Town Clerk), Rev J Pearce (Mayor's Chaplain), Dave Farrow (Head of Outcomes and Sufficiency, Education Department, Somerset County Council) and Duncan Richard (Yeovil Men's Shed).

There were 8 members of the public and 0 members of the press present.

**Public Question Time** - There were no questions from the public.

Dave Farrow (Head of Outcomes and Sufficiency, Education Department, Somerset County Council) gave a presentation about Education. He informed that Council the Early Years Provision and that 90% of settings were judged as good or better (compared to the national average of 91%). All primary schools within Yeovil Town had been judged as good or better (compared to the national average of 90.4%). There was a disparity for Pupil Premium children's progress for both Key Stage One and Two. All secondary schools within Yeovil had been judged as good (compared to the national average of 78.6%). Higher Education requirements were also discussed. School Place Planning was highlighted, with an increase of pupil numbers from 2009-2016 of 14% and a forecast increase by 2021 of a further 7%. Dave Farrow spoke about how this additional need would be met.

8:15pm – Dave Farrow and 1 member of the public left the meeting and did not return.

Duncan Richard (Yeovil Men's Shed) gave a presentation and demonstration about Yeovil Men's Shed. They now have 53 members of which 10 were women. Many organisations are requesting that Yeovil Men's Shed work on projects for example, Bird Boxes for Yeovil Country Park. They also work very closely with Grovelands (a care home that provides residential and dementia care) and encourage residents to take part in activities. Yeovil Men's Shed is now looking for bigger premises. Duncan Richard thanked the Council for the financial assistance given.
