## 8/245 <u>REPRESENTATIVE FROM AVON AND SOMERSET POLICE</u> <u>CONSTABULARY</u>

Sergeant Richard Barnett was unfortunately unable to attend the meeting. However, PCSO Andrea Bowditch was in attendance to note any questions or issues and refer them back to her colleagues. The issue raised was concern about unauthorised traffic in pedestrianised areas in the Town Centre, and a question was raised about the authority of Police Community Speed Watch.

## 8/246 WEST COKER ROAD

It was explained to the PCSO that the Highways Authority had consulted the Police on the request for pedestrian refuges along West Coker Road. The comments received from the Police via the Highways Authority had included the following statement "that the A30 West Coker Road is a major abnormal load route to the Dorset area, the majority of these abnormal loads are 3.95m wide but some can be up to 4.8m wide. Therefore, the provision of refuges along this route would prevent these movements and unfortunately there is no alternative..."

PCSO Andrea Bowditch was therefore requested to ask her colleagues what criteria the Police used to object to the requested pedestrian refuges along West Coker Road.

- (2) that the PSCO refer the question to the relevant Police department, and their response be reported to a future meeting; and
- (3) that PCSO Andrea Bowditch be thanked for her attendance at the meeting at short notice.
