## **Recording of Council Meetings**

The Local Audit and Accountability Act 2014 allows both the public and press to take photographs, film and audio record the proceedings and report on all public meetings (including on social media).

Any member of the public wishing to record or film proceedings must let the Chairman of the meeting know prior to, or at the start of the meeting, and the recording must be overt (i.e. clearly visible to anyone at the meeting), but nondisruptive. This permission does not extend to private meetings or parts of meetings which are not open to the public.

### Equality Act 2010

## Human Rights Act Statement
