Minutes of the meeting of Yeovil in Bloom Steering Group held on Monday 18th October 2021 at Lufton Nursey, Artillery Road, Yeovil, BA22 8RP.

Also Present: Eleanor Goulding (Denman and Gould) and Zoe Li (Yeovil Art Space).

In Attendance: Sally Freemantle – Deputy Town Clerk.

1.35pm – meeting commenced.

1. Apologies for Absence

Apologies for absence were received from David Recardo.

2. Minutes

To approve as a correct record the minutes of the last meeting held on 6th September 2021, with the amendment of the "Meeting Closed" time from 2.54pm to 3.04pm.

Resolved: that with the amendment of the "Meeting Closed" time from 2.54pm to 3.04pm that the Minutes of the meeting of Yeovil in Bloom Steering Group held on 6th September 2021 be signed by the Chairman as a correct record.

3. Yeovil Arts Action Group Commissioned Artists

Eleanor Goulding from Denman and Gould introduced herself and gave a presentation on the work of Denman and Gould and some of the projects she and her partner have worked on in Southampton, Winterbourne Abbas, Lydney Harbour, Cribbs Causeway (Bristol) and London. Eleanor explained that the community aspect of public art was very important and recent collaborations had included rewilding and reintegrating wildlife into public spaces through art forms. Exploration of the connection of humans with nature and supporting communities in re-engaging with their surroundings had been an important part of the process. Eleanor explained

that the ability to engage with the community from the outset would enhance the ability to gain community insight into an outcome which would be fitting and relevant. More information about the projects and work can be found at <u>www.denmangould.com</u>

4. Yeovil in Bloom Results 2021

Steve informed the Group that Yeovil had won Silver Gilt in the 2021 South West in Bloom Competition. Feedback sheets were distributed to members of the group and Steve highlighted the areas for improvement. The Steering Group felt that Steve had done a tremendous job in difficult circumstances and Steve commended the early morning team who took great care in feeding and watering the plants which produced such beautiful and long-lasting displays.

Steve also announced that Yeovil had won a "Joint Inclusive Gardening Award" and was congratulated by the Steering Group.

5. Yeovil in Bloom Designs for 2022

Steve informed the Group that the designs for next year would incorporate the Queen's Platinum Jubilee.

It will be the 25th anniversary of Yeovil entering into the South West in Bloom Competition.

Steve summarised some of his outline ideas including a gold colour scheme, a redesign of the edible garden in Bond Street and re-purposing of basket trees with big planters in St John's Churchyard. More detailed designs will be brought to the next meeting.

6. Yeovil in Update

Steve informed the Group that the Yeovil in Bloom team would be one member short soon due to a resignation/vacancy.

10/154 BLOGGING PROPOSAL FROM CALISMEDIA

To consider the proposal below:

What is CalisMedia?

CalisMedia is an audio media production company specialising in podcasts. Think of us as a bit like Netflix or Amazon for podcasts. Different shows for all types of people and interests with our ambition being to have an enormous catalogue of shows on a website or app one day. We are the first media company of this kind in Yeovil. In just a handful of months I have been able to make social media content that is viewed widely and podcast and YouTube content that is varied, education, interesting and fun. Thanks to relentless study and trial and error I am becoming an accomplished social media marketer, I intend to use these skills to make sure CalisMedia has a platform that can be used to promote local businesses and causes.

What is a podcast?

A podcast is a lot like listening to the radio, except you listen to what you want, when you want. The appeal of Sonys original Walkman and Apples ipods were in the autonomy given to you to listen to whatever you feel like listening too, no adverts, no annoying DJs you have to put up with. Just pure choice. That's what a podcast is. They are audio shows that you subscribe to and download at your convenience. There are dozens of Podcast apps and the popularity of podcasting exploded to such a degree that the planets largest companies, Apple and Google, now have their own specially designed apps just to try and get a foothold in the expansive podcasting market.

The app 'Spotify' boasts **345** million monthly listeners (<u>Spotify User Stats (Updated Oct</u> <u>2021</u>)), 53 percent of those listeners also listen regularly to podcasts. That's just on one app. As of 2019 it is recorded that 82% of podcast listeners, listen to podcasts for more than 7 hours each week. While driving in their car, while running or walking or doing errands around the house. It's the perfect companion.

The benefits of social media are vast and many and I doubt I need to go into too much detail about that here. But I am becoming more and more able to use that enormous potential of facebook and Instagram to my advantage.

CalisMedia is a podcast production company that produces a number of new and excellent shows aimed at a diverse range of listeners. Our goal is to be the most visible media content producer, not only in Yeovil, but in the whole of the UK. A big goal, but with my raw determination and with your help, its an achievable one. We need to be seen.

I can attract big names to the town, I can draw big crowds to live events and I can get everybody listening to our shows. i can make CalisMedia yeovils most successful ever media export which means that Yeovil will be seen. Our planned live events mean that we can have guest speakers from the council or any project that the council wants to shine a light on, our long form podcasts mean that we can explore Yeovil, its ideas and its people in real depth and tell some amazing stories and keep people informed of whats going on in there town, how much time might you be allotted on something like a local radio station? A few minutes? What if there was no time limit? What if using humour and entertainment we can talk about whatever issues are pertinent to the council, for as long as we wanted. *That* is why new media, like podcasting, is becoming so important to people.

How does this benefit Yeovil town?

My company and my social media approach are modern and effective and, for Yeovil town, it would be a bold, unique and innovative move to choose to work with me to utilise podcasting and social media to reach people in the town using clever marketing techniques and eye catching videos and shows. With no money I have been able to reach a large portion of Yeovils people, I have built a company that people are starting to trust and recognise. When I interview celebrity guests I will, where possible, interview them in places that the council would want to draw some attention too. Country parks, coffee shops, the town centre post the regeneration project.

During/at the end of every podcast episode I will insert a pre-recorded advert for Yeovil. It could be for specific events the council wants to highlight or a 'Visit Yeovil' tourism type angle. I would also put advertisement images in any and all posts that are on facebook and Instagram. As CalisMedia grows so will the Yeovils exposure. Imagine how curious people outside of the town would be once they started seeing well known celebrities being photographed and recorded in Yeovil. I can achieve this without too much difficulty, but It comes at a cost that I can not pay without your

help.

Funding would enable me to work with professional filmmakers and photographers to produce uniquely Yeovil content that will make people notice us, notice your improvements to the town centre.

With my ambition, imagination and love for this town I can help Yeovil do something that isn't being done elsewhere.

What do I need?

I have managed to make some noise with the company and be seen by a lot of people whilst working 14 hour days in two jobs and trying to be the best father and partner I can be. I take those responsibilities seriously. Up until recently I have produced the entire CalisMedia company on my partners Ipad in our front room. I go to bed about midnight and wake up at five AM to get a head start on my competition and then to start the long working day.

If you can see the success we have had so far in reaching people, then I would ask you to imagine what I could achieve if I also had financial backing. Here are the things I would do if given significant financial investment:

 Using local film makers and creatives I would produce a short, snappy advert for CalisMedia and put a few hundred pounds into the facebook and Instagram circulation of that using an advertising method known at the moment as the 'Gary Vaynerchuk' method. Which involves releasing an initial facebook-boosted post, retracting it after a few days and then sending it back out targeting a different subset of facebook users who the algorithm registered as being the most interested. On that second post we put a CTA (call to action) encouraging people to visit our websites.

- I would want to look into getting our logo seen wherever possible, via posters, advertising boards and perpetual paid adverts on Instagram, facebook and twitter. (we will utilise tiktok more too once we have enough content to release)
- It is easier than you might think to get the attention of celebrities. One of my very first goals would be to try and
 get some famous faces to help us promote CalisMedia and by extension Yeovil. With financial help I would
 utilise websites that specialise in connecting you with Celebrities. It is easy, but pricey by my current budgets
 standards, to pay famous people to make social media posts that say whatever we want them to say. We can
 attract big names to the show and put them up in local hotels, we can take pictures with them at Yeovil
 hotspots.
 - Investment would mean that I could use and experiment with different Software/hardware for my recently
 acquired laptop. There are countless wonderful, game changing applications behind a paywall that I cannot
 currently access due to budgetary constraints.

- Investment would also mean that we could put on regular live podcast recordings. We could hire venues and
 put on shows where we could have guest speakers about any topic we want. We could hire the swan theatre
 for a couple of nights or even the octagon theatre and regularly showcase the very best performing talent
 yeovil has in variety show form.
- Financial help would mean that we could work closely with local companies to do promotions and giveaways with them. I could purchase a certain amount of their product/service and then give it away in a competition aimed at improving ours and their social media presence

Every aspect of what we do will be improved, honed and highlighted if we had help and we will get out of this project what we put into it. Here is a more plain breakdown of what I could do with certain sums of money a month:

- £1000 a month would mean that I immediately and exponentially grow our social media platform. Within twelve months we would be a widely recognisable presence in yeovil, capable of helping with promotion.
- £2000 a month would mean that CalisMedia would quickly become Yeovils most visible media company. We would attract high quality names and faces to our shows and social media platforms. We could achieve a great deal and in twelve months be a mighty media arm for the council and for all my productions.
- £3000 a month would mean that I could quit my current job and work full time on CalisMedia. I could travel to meet guests, I could improve the technology we use and spent more time working on high volume and quality social media output. We would aim to boost our profile so much that we rival any news media or radio platform in the south west of the UK.

I hope this document is clear. I look forward to talking with you all and answering any questions you have about CalisMedia and our ambition. I will make this company something big and something special and I would love representatives of Yeovil Town and its council to get on board with it in these early days so that we could partner in something new, something exciting and something extraordinary.
