Minutes of the hybrid meeting of the Grounds and General Maintenance Committee held on Monday 22nd May 2023 at 7.00pm held in the Town House, 19 Union Street, Yeovil BA21 1PQ and by video-conference using Zoom meeting software.

Public Comment.

There was one member of the public in person and one member of the press present virtually. The member of the public commented on the poor state of Eizabeth Flats Allotment site and gave some specific details which were noted for investigation.

11/083. APOLOGIES FOR ABSENCE AND TO CONSIDER THE REASONS GIVEN

Apologies for absence were received from Cllrs T Casey (conflicting engagement), P Lock (unwell) and J Snell (family commitment) although present virtually. (*LGA 1972 s85(1)*).

RESOLVED: to accept the apologies with the reasons given.

11/084. DECLARATIONS OF INTEREST

There were no declarations of interest.

11/085. MINUTES OF LAST MEETING

The Committee approved as a correct record the Minutes of the previous meeting held on 13th March and 9th May 2023.

RESOLVED: that the Minutes of the meetings of the Grounds and General Maintenance Committee held on 13th March and 9th May 2023 be signed by the Chairman as a correct record.

11/087. PLAY AREA REPAIRS, SCHOOLS OUT PROGRAMME AND PLAY AREA IMPROVEMENTS

The Locality Officer from Somerset Council gave an overview of the report and Committee Members asked the following questions:

- Update on Arnewood Park Gardens (Turners Barn Lane) Play Area
- Inspection Reports on Play Areas
- School's Out Timetable

The Locality Officer stated that the above information would be forwarded to the Committee via the Deputy Town Clerk. The Locality Officer also informed the Committee that work will start shortly on the tennis courts at Yeovil Recreation Centre and Cllr Kendall commented that it is not possible to book the tennis courts online.

The Locality Officer added that there will be a play day at Milford Park on 24th August which would mark the official opening of the skate park.

11/088. SKATE PARKS UPDATE

The Locality Officer gave an update on the skate park projects and explained that an extra path had been added to the Milford Park skatepark within budget.

RESOLVED: that the report be noted.

11/089. ALLOTMENT LETTING/AVAILABILTY REPORT

The Committee considered the report by the Assistant Town Clerk who was congratulated on managing the allotment lettings to 95% occupancy. It was noted that Elizabeth Flats Allotment site had particular issues which had been reported by during Public Comment.

11/090. FEEDBACK FROM YEOVIL ALLOTMENT ASSOCIATION BY THE REPRESENTATIVE FROM YEOVIL TOWN COUNCIL

The Yeovil Town Council representative had unfortunately not been able to attend the meeting of the Yeovil Allotment Association and it was suggested that if the representative is unavailable, Cllr R Spinner attend instead. The Deputy Town Clerk explained that she would check this arrangement with the Yeovil Allotment Association.

RESOLVED: that in the absence of the Yeovil Town Council representative, Cllr R Spinner attend the attend the Yeovil Allotment Association meetings subject to this being acceptable to the Yeovil Allotment Association.

11/091. FEEDBACK FROM CO-OPTED NON-VOTING MEMBER

The Co-opted Non-voting member stated that the noticeboard on Milford Dip Allotment site had not been installed and that the letter had been sent to the wrong tenant. The Deputy Town Clerk explained that more than one tenant had been sent a letter as the noticeboard location may span more than one plot. The Assistant Town Clerk asked for clarification on whether the noticeboard needed to be viewable by people outside of the allotment site and the Co-opted Non-voting member confirmed that it did not.

It was confirmed that the assessment of the sheds is a scheduled task. It was asked whether the trackway at St George's could be checked as the Co-opted Non-voting Member had received an email to say that the central ridge was getting too high for cars to pass over easily.

7.42pm Cllr J Lock left the meeting.

It was requested that the brambles on the corner of Milford Road leading into Milford Dip be cut back.

7.45pm Cllr J Lock returned to the meeting.

The Co-opted Non-voting Member commented that it was nice to be working with the Assistant Town Clerk again.

He stated that there was still no feedback when issues were raised regarding the issuing of Notices to Quit. It was commented that information about individual tenants and their tenancies could not be disclosed due to GDPR.

RESOLVED: that the update be noted.

11/092. OPEN SPACES REPRESENTATION

The Committee considered a table which identified the open spaces in the Town and the ward representation by Committee member of each open space in 2022/23. The agreed representation from this Committee for the open spaces in Yeovil Town are listed in the table below.
