FEES OPERATIVE FROM 1ST APRIL 2025 AT YEOVIL CEMETERY

The fees listed below are applicable to the residents (Parishioners) of Yeovil, i.e., the parishes of Yeovil Town, Yeovil Without and Brympton.
For Non-Parishioners, i.e., residents of the Yeovil area but not within the above Parish's, the fees are doubled. If the deceased moved into a residential care home, less than 12 months prior to the date of death, the fee would remain at the standard rate.

<p>The burial of the body of a person whose age at the time of death</p> <ul style="list-style-type: none"> ■ Exceeds sixteen years (Single Depth) £750 ■ Exceeds sixteen years (Double Depth, additional fee) £150 ■ Hand dug grave (additional fee) £240 ■ The burial of Cremated remains £290 ■ The use of the Cemetery chapel £153 <p>Babies and Children up until the age of 16 will not be charged for interment. Charges exist at current prices for the Chapel and burial plots. Subject to criteria burial plots and services may be covered by the Children's Funeral Fund for England (CFF).</p>	
<i>BURIAL AND MEMORIAL RIGHTS</i>	
(for a period of 75 years – subject to review)	
<p>The purchase of burial and memorial rights:-</p> <ul style="list-style-type: none"> ■ In the remainder of the cemetery (single depth common) £913 ■ Double Depth Grave (common or otherwise) £1826 ■ Grave for cremated remains only £550 ■ Family grave for cremated remains only - up to 6 sets £913
